**PHASE 1:
ENROLLMENT**

- \$250.00 ENROLLMENT FEE (MONEY ORDER)
- PICTURE ID
- SOCIAL SECURITY CARD OR VERIFICATION OF THE NUMBER (PAY STUB,
- REMAIN CRIME FREE/DRUG FREE
- KEEP THE AIP/TREATMENT PROVIDER OFFICES AWARE OF ANY ADDRESS OR TELEPHONE NUMBER CHANGES
- CRIMINAL HISTORY CHECK

**PHASE 2:
COUNSELING**

- CONTACT TREATMENT PROVIDER WITHIN 24 HOURS OF YOUR ENROLLMENT TO SET UP COUNSELING SESSIONS
- \$100.00 COUNSELING FEE (MONEY ORDER ONLY)
- 4 TWO HOUR COUNSELING SESSIONS *****17 and under PARENT OR GUARDIAN REQUIRED
- ANY EXTENUATING CIRCUMSTANCES REGARDING CLASS ATTENDANCE MUST BE APPROVED BY THE TREATMENT PROVIDER. **EMERGENCY ONLY!**
- THE MAKE-UP CLASS WILL BE AN ADDITIONAL \$25 (ONE ABSENCE ONLY)
- COMPLETION OF AIP WILL TAKE NO LONGER THAN 60 DAYS
- REMAIN CRIME FREE/DRUG FREE
- KEEP AIP/TREATMENT PROVIDER OFFICES AWARE OF ANY ADDRESS OR TELEPHONE NUMBER CHANGE

**PHASE 3:
COMMUNITY SERVICE**

- UP TO 40 HOURS OF COMMUNITY SERVICE WILL BE REQUIRED. AIP COORDINATOR WILL ADVISE OF LOCATION. YOU ARE TO REPORT TO COMMUNITY SERVICE SITE ON DATE ASSIGNED.
- KEEP AIP/TREATMENT PROVIDER/COMMUNITY SERVICE SITES AWARE OF ANY ADDRESS OR TELEPHONE NUMBER CHANGE

**PHASE 4:
COMPLETION**

- SUCCESSFUL COMPLETION FROM AIP/TREATMENT PROVIDER/COMMUNITY SERVICE SITE
- \$150.00 EXPUNGEMENT FEE (MONEY ORDER ONLY)
- THE PARTICIPANT IS RESPONSIBLE FOR FILING THE EXPUNGEMENT ORDER WITH THE CLERK OF COURT AND PAYING TRUE COPY FEES
